- The innovation can be a product / service / project / system/ process / procedure / methodology
- Must be already implemented in India between 1 January 2015 and 31 December 2018 and should not be in a planning or conceptualizing stage

## INSTRUCTIONS FOR FILLING THE FORM

- Application form needs to be filled with relevant information in the English language only.
- Please use **permanent ink** while filing the form. Please initial any cancellations / over writings made in the form
- **As per the category applied, relevant sections need to be filled by the participant**
- All details of the form should be complete in all respects. Incomplete form may be disqualified.
- Once complete, the application form must be signed by authorized signatory from the participant organization (from amongst the MD, CEO, COO, chairman or proprietor). Unsigned forms may not be considered. Declaration form is attached on the last page and **must** be signed and stamped. The application may not be considered if the declaration is not signed or stamped
- Please provide up to 10 supporting documents (photographs, project plan, floor plan, site design, energy audit certificates, etc.) wherever possible, to support your entry details
- Additional sheets can be attached wherever required.
- Please maintain one copy of the filled form for your records
- You may participate in multiple categories.
